

## Rules of the event

### "Children's Day – in little Mayer's fun world" (hereinafter referred to as "Regulations")

1. Is of an educational and artistic nature.
2. Date and Time: The event will take place on June 2, 2024, from 11:00 AM to 3:00 PM.  
**Organizer: The event is organized by the POLIN Museum of the History of Polish Jews, located at 6 Anielewicza Street, 00-157 Warsaw. Contact: Phone: 22 471 03 01, Website: [www.polin.pl](http://www.polin.pl), email: [polin@polin.pl](mailto:polin@polin.pl).**
3. Participation in the event requires familiarization with and adherence to these Regulations. Non-compliance may result in the involvement of appropriate security services to remove the participant from the event or take other measures to prevent violation of the Regulations.
4. Entering the event area constitutes acceptance of the Regulations. Acceptance of the Regulations is necessary for participation in the event.
5. The event is open to the public and free of charge. Minors can participate only under the supervision of an adult guardian who is responsible for any damages or accidents caused by themselves or the minors under their care.
6. The event includes the following activities (hereinafter referred to as "activities"):
7. Family workshops in the form of an outdoor game, family animations, circus shows and workshops, workshops with an organ grinder, painting area, toddler zone with sensory animations, tour of the temporary exhibition, gastro zone combined with a relaxation zone. Participants are required to follow the instructions and commands given by the organizers' representatives conducting the activities.
8. Pets are allowed in the event area only under the owner's supervision and responsibility, provided they do not hinder participation in the event.
9. The presence of individuals under the influence of alcohol, drugs, or other similar substances is prohibited. Consuming alcohol, drugs, or similar substances at the event is also forbidden.

10. Smoking, bringing dangerous materials or items (especially weapons, fireworks, sparklers, knives), and using open flames are strictly prohibited.
11. Littering and leaving food or drink residues are not allowed.
12. Please note that photographs and videos will be taken during the event and will be published on the Museum's social media (e.g., Facebook, Instagram) and websites for promotional purposes and in connection with the Museum's statutory activities of promoting and conducting artistic and cultural dissemination activities.
13. Obscene behavior, offensive language, displaying banners with obscene, vulgar, racist, or otherwise harmful content, and inciting conflict on national, religious, or social grounds are prohibited.
14. Damaging, destroying, or stealing event elements is forbidden.
15. Security services of the Organizer and municipal security services have the right to remove individuals violating the Regulations from the event area or take other appropriate actions to prevent breaches of the Regulations.
16. The event area is constantly monitored. In case of a threat, participants should:
